ASSOCIATION POOL POLICIES

The CERA Board of Directors and the Pool Manager set all policies and rules. Failure to comply could result in the loss of your membership. It is your responsibility as a member to make certain that all of your family and guests who use this recreation facility are fully informed of the rules and policies.

POOL RULES: 2011

1. **A MEMBER MUST ACCOMPANY ALL GUESTS. \$1.00 per guest.**
2. All members must sign the pool registry book upon entering. Register your guests and pay fees at this time. If after hours, use money drop.
3. Pool hours are 9:00 a.m. to 11:00 p.m. daily, except on Monday when it opens at 12 Noon. **NO ADMITTANCE AFTER 11 P.M. BY ANYONE !**
4. A lifeguard is on duty from 2 p.m. to 7 p.m. on weekends and every day after school is out until it resumes in August.
5. **No one under 18 may be left at the pool without Adult supervision.**
6. **All children are the *direct responsibility of their parent(s) at all times.***
7. The lifeguard will be obeyed at all times.
8. NO HORSEPLAY OR RUNNING WILL BE ALLOWED.
9. No diving from the side of the pool in shallow areas.
**** NO DIVING FROM THE LIFEGUARD STAND ! ****
10. Do NOT distract the lifeguard or engage in conversation.
11. Any object or pool toy is subject to removal from the pool at the request of the Lifeguard or Pool Manager.
12. Absolutely **NO PETS INSIDE THE FENCED AREA**, except for handicap assistance.
13. Do not swim if you have bandages and/or open wounds.
14. **NO GLASS** of any kind allowed inside the fences.
15. Food, drink, and smoking are restricted to the grassy areas and pavilion.
16. No gum in the pool.
17. Swimsuits only in the pool. No un-hemmed cutoffs allowed.
18. No one is allowed in the pump house unless authorized by the Manager, Lifeguard or Board of Directors.
19. No ALCOHOLIC beverages allowed inside the fenced area, **No disposable diapers.**
20. Children of existing members who live in the local area are allowed to use the CERA pool facilities until they reach the age of 26, at which time they will be required to obtain their own membership to the CERA pool

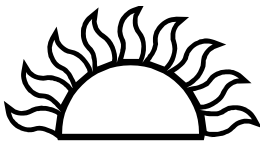
PARTY and GROUP USE: * * * Please note changes * * *

All parties and group use must be scheduled through the Pool Manager. The member who reserves the pool must be present for the entire party. All parties will require two lifeguards to be present. There is a **\$50.00** charge for the first hour, additional hours are charged at **\$40** per hour.

- **Exclusive pool use** may be reserved **ONLY on Tuesday evenings** from 6:00 to 9:00 P.M. and **must be scheduled with the Pool Manager.** It is the member's responsibility to clean up their area after the party.
- **Non-exclusive pool use:** This is a non-exclusive use of the facilities for any time or day of the week before June 1st and after August 15th, and **must be scheduled with the Pool Manager.** June 1 through Aug 15th, parties and group use is limited to party times outlined. It is the member's responsibility to clean up their area after the party.
- If more than two lifeguards are needed, additional charges may apply. These rates apply to **ALL** party and group use unless the group is 10 or fewer in number, then only guest fees apply. For the convenience & safety of all our members, **even these small groups are to be scheduled with the manager.**
- ---> If the group is more than 50 people, **this includes ANYONE coming through the gate, whether swimming or not swimming**, the rates are charged at \$100 per hour for all hours.
- **Party Times** - Parties larger than 10 people may schedule the pool for **Saturday from 10:00 a.m. to Noon and on Sundays from 6:00 -9:30 p.m.** *This is a non-exclusive use of the facilities and must be scheduled with the Pool Manager.* A **\$50.00 NON-REFUNDABLE DEPOSIT** is due when the reservation is made to guarantee date and time of party. Member will be given 15 minutes for setup and no more than 30 minutes for clean up when party period ends. Additional charges may be assessed for staying beyond these deadlines.

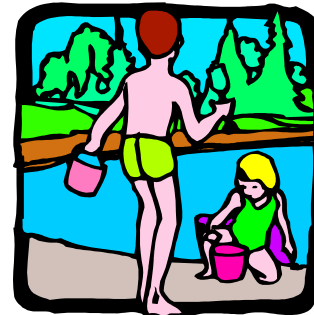

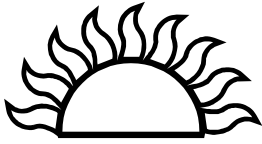
